Pro se Motion to Modify Probation or Community Control

Motions to modify your probation or community control are *related* to your criminal case, but the Public Defender **cannot** file these motions for you or represent you in your hearing unless the Court appoints us to do so.

There are *three* forms attached that we hope will help you with this matter: (1) Defendant's Motion to Modify Probation/Community Control; (2) Notice of Hearing; (3) Order Modifying Probation/Community Control.

INSTRUCTIONS FOR PREPARING AND FILING YOUR MOTION

- 1. Contact your probation officer to let him/her know you will be filing this motion and find out if your probation officer has any objection to the motion.
- 2. Fill out all of the attached forms correctly.
 - o In each document's "heading," circle either COUNTY (for Misdemeanor cases) or CIRCUIT (for Felony cases) and the County in which your case is filed.
 - O Write in your name, case number, and the court division.
 - o Fill in all of the spaces where you see a "
 - O Where you see words separated by a slash mark (/), you need to circle one of the words.
 - o Write the current date in the last paragraph of the Motion and Notice of Hearing.
 - **DO NOT fill in the court date or time on the Notice of Hearing.
 - o Sign on the line above "DEFENDANT, PRO SE" on the Motion and Notice of Hearing.
 - o Write your telephone number and address in the blanks below your signature.
 - Write the name and telephone number for your probation officer.
 - **DO NOT sign and DO NOT write a date on the Order. The judge will sign and date the order in court.
- 3. Once you have the specific instructions from the court, make 4 copies of the Motion and Notice of Hearing.

- 5. The Judge will notify you in the mail of a hearing date or final disposition of your motion. The Judge may deny or grant your motion without a hearing. Additionally, you can check the status of your motion on the Clerk's website.
