Pro se Motion to Return Property

The Office of the Public Defender cannot file these motions unless the Court has appointed us and we remain your attorney at the time you request the return of property. These are three forms attached to this packet that we hope will help you with this matter: (1) Defendant's Motion to Return Property; (2) Notice of Hearing; (3) the proposed Order to be signed by the judge.

INSTRUCTIONS FOR PREPARING AND FILING YOUR MOTION

- 1. Fill out all of the attached forms correctly.
 - In each document's "heading," circle either COUNTY (for Misdemeanor cases) or CIRCUIT (for Felony cases)
 - Write in your name, case number, and the court division.
 - Fill in all of the spaces where you see a "
 - Where you see words separated by a slash mark (/), you need to circle one of the words.
 - Write the current date in the last paragraph of the Motion and Notice of Hearing.
 - **DO NOT fill in the court date or time on the Notice of Hearing.
 - Sign on the line above "DEFENDANT, PRO SE" on the Motion and Notice of Hearing.
 - Write your telephone number and address in the blanks below your signature.
 - Write the name and telephone number for your probation officer.
 - **DO NOT sign and DO NOT write a date on the Order. The judge will sign and date the order in court.
- 2. Once you have the specific instructions from the court, **make 4 copies** of the Motion and Notice of Hearing.
